The cabin and the story of its builder, a trained carpenter and the son of an enslaved woman, provide a vital link to our shared past. The rehabilitation of the south-facing windows to their 1947 appearance and the addition of a ramp for accessibility are critical steps towards preserving this historic gem for future generations. The significance of this project in preserving and rehabilitating the Zephyr View Cabin aligns seamlessly with the purpose and goals of the State Historical Fund.

As you well know, Lincoln Hills was founded in 1922 as a resort community by Black Americans, for Black Americans, providing a sanctuary and recreational opportunities at a time when segregation and racial discrimination were rampant. It served as a beacon of hope and a sanctuary for Black communities in Colorado and beyond. The history of Lincoln Hills represents an essential chapter in the fight for civil rights and the struggle against racial segregation in our state and nation.

The Gilpin County Board of County Commissioners recognizes the cultural, historical, and educational value of the Zephyr View Cabin and fully supports the efforts to ensure its continued preservation and accessibility. We believe that this project is not only a testament to the resilience and contributions of Black communities but also an opportunity to educate and inspire future generations about the significance of Lincoln Hills in our history.
