To Create Safe Area for Customers and Secure Area for Storage of Alcoholic Beverages:

- Proper commercial quality locks with deadbolts used at all entrances and exits
- Wifi security cameras in strategic locations
- Restricted access behind the bar

To Prevent Service To Minors And Intoxicated Individuals:

- All servers of alcohol TIPS or equivalent certified (current, not expired)
- Non alcoholic beverage options are offered
- Training of policy to check IDs for anyone who appears to be under 50 years old
- Current ID book accessible to servers
- Written posted notification and distributed employee policy that we will refuse service to anyone we choose, particularly individuals exhibiting signs of intoxication
- Tasting room will close promptly at closing time

To Prevent Customers Leaving Premises With Open Containers of Alcohol:

- Outdoor area enclosed by fencing and a small area with rope/chain
- Signs posted at all exits indicating No Alcohol Beyond This Point
- Exit out of sight of typical service line of sight designated and posted as Emergency Exit Only
