10 things you can you do with an ACP substitute address

- 1. Place your ACP address on your driver's license.
- 2. Place your ACP address on your vehicle title and registration.
- 3. Use your ACP address as your legal address on all court documents, police reports **and** any legal documents that have been created up to 90 days **before** you even enrolled.
- 4. Use your ACP address to enroll your child in a new school.
- 5. Have the ACP transfer your child's old school records to the new school. The old school will not have the new school information.
- 6. Use your ACP address to get a new library card.
- 7. Use the ACP address for your Xcel energy account.
- 8. Place your ACP address on your checking account and order new checks.
- 9. Use your ACP address for filing taxes.
- 10. Register to vote as an ACP voter. ACP voters have the highest level of voter confidentiality available in Colorado.

Substitute Address and Mail Forwarding – Do I have to have both?

The ACP is a flexible safety planning tool that gives you options. The ACP can forward mail to your real address, a P.O. Box or any other address. Just remember that wherever you use your substitute address, any mail generated from that source will go to the ACP and will be forwarded to you.

Remember that the more you use the substitute address, the less likely you are to be connected with your real address. Here are some of the options:

- You can use the substitute address for one or two public records. Maybe you just want to register to vote as an ACP voter. Maybe you just want to protect your driver's license and vehicle registration.
- You can treat the substitute address as your real address (the ACP's recommendation). You can use the substitute address for all personal mail and all public records.
- You can have a P.O. Box and the ACP substitute address. You can have the ACP forward mail to your P.O. Box, and receive your magazines and packages at your P.O. Box.
