WHEREAS, by Quitclaim Deed dated July 26, 2016 and recorded on July 26, 2016 at Reception No. 156841 in the real property records of Gilpin County, Colorado, GILPIN COUNTY, COLORADO, a political subdivision of the State of Colorado conveyed the property to the City:

WHEREAS, per the 2017 Abstract of Assessment of Gilpin County, 73.1% of the County assessed value originates from property within Central City and Black Hawk and increased economic activity within the cities will directly increase the values of property and therefore property tax collected in that area, which in turn will provided increased County property tax collection and will support needed County services; and

WHEREAS, a revitalized Belvidere will help diversify Gilpin County's economic base and will provide a performance venue, a meeting space or other area for all-ages activities; and
